**Year 2007** SENATE ORDER ON DEPARTMENTAL AND AGENCY CONTRACTS LISTING RELATING TO THE PERIOD 1 January 2007 - 31 December 2007

Pursuant to the Senate Order on departmental and agency contracts the following table sets out contracts entered into by the CrimTrac Agency which provide for a consideration to the value of \$100 000 or more and which:

- a. have not been fully performed as at 31/12/2007 or
- b. that have been entered into during the 12 months prior to 31/12/2007.

A number of the contracts in the table contain mutual confidentiality provisions that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract. These are referred to as, 'other requirements of confidentiality' and require each party to seek written consent before disclosing any confidential information of the other party to a third party. The reasons for including such clauses include:

- ordinary commercial prudence that requires protection of trade secrets, proprietary information and the like, and/or
- protection of other Commonwealth material and personal information.

Unless there are other requirements of confidentiality, the column relating to the reasons for, 'other requirements of confidentiality' is left blank.
